Notice Concerning Completion of Acquisition of Trust Beneficiary Interests in Domestic Real Estate (Prime Maison EBISU)

Sekisui House SI Residential Investment Corporation (the "Investment Corporation") hereby announces that it completed the acquisition of trust beneficiary interests in real estate on January 15, 2015 for Prime Maison EBISU among the 8 properties to be acquired as described in the press release titled "Notice Concerning Acquisition of Trust Beneficiary Interests in Domestic Real Estate and their Leases (Prime Maison MORISHITA and 7 Other Properties)" dated October 3, 2014. In addition, the Investment Corporation announces that the trust expiration date and the lease contract expiration date, which were initially undecided, have been determined as follows.

Furthermore, the trust beneficiary interest transfer agreement concerning the acquisition of Prime Maison EBISU is with condition that the Investment Corporation reasonably concludes the occupancy rate has reached a level with which the Investment Corporation is satisfied on the planned date of acquisition. The Investment Corporation has judged that the condition has been met based on the information provided by the seller. According to that information, the occupancy rate as of January 12, 2015 was 96.6 %.
