Notice Concerning Acquisition of DBJ Green Building Certification for Residential Properties for the First Time among J-REITs

Sekisui House SI Residential Investment Corporation (the "Investment Corporation") hereby announces that it today received DBJ Green Building Certification for two of its owned properties (Prime Maison SHINAGAWA and Prime Maison GOTENYAMA EAST) from Development Bank of Japan ("DBJ") in recognition of their exceptionally high "environmental and social awareness", as described below. This is the first case of the Certification granted to residential properties.

1. Overview of DBJ Green Building Certification

The DBJ Green Building Certification System (the "System") is designed to mark buildings by using a scoring model originally developed by DBJ and select blue-chip real estate that meets the demands of the times. Its purpose is to promote real properties that demonstrate environmental performance as well as security measures and disaster prevention measures and take into account the social requirements from various stakeholders surrounding the properties ("Green Buildings").

☐ "Gohon no ki" (Five Trees) project Promoted by Sekisui House, Ltd.


The "Gohon no ki" (Five Trees) project is a proposal for creating gardens to facilitate communications with nature, promoted by Sekisui House, Ltd, the main sponsor of the Investment Corporation.
