### 4. Future Efforts by the Investment Corporation

Since establishing environmental basic policy and sustainability policy and objectives on March 31, 2015, the Investment Corporation has been promoting initiatives for energy saving and environmental awareness in response to the requirements of the times through such measures as enhancing energy efficiency of its owned properties and acquiring environmentally friendly properties. To do so, the Investment Corporation has been cooperating with Sekisui House, Ltd., the sponsor, which has been certified as an Eco-First Company\* by the Minister of the Environment for the first time in the housing industry.

Furthermore, although an absorption-type merger, with May 1, 2018 as the effective date, whereby the Investment Corporation will be the dissolving corporation and Sekisui House Reit, Inc. will be the surviving corporation in the merger ("Investment Corporation Merger") is scheduled to be executed as announced on January 24, 2018, the policies, etc. mentioned above will be adhered to even after the Investment Corporation Merger and we will further promote sustainability activities such as implementation of measures to mitigate environmental impact.
